

Rental Terms & Conditions

Brian Foster Solutions LLC • Lancaster / Palmdale • Tools now, trailers coming soon

These Rental Terms apply to all equipment rentals provided by Brian Foster Solutions LLC ("Owner"), including tools and, when available, utility trailers. By renting equipment, the renter ("Renter") agrees to the terms outlined below.

1. Rental Period

- Standard rental period is 24 hours, unless otherwise agreed in writing.
- Rental time begins at the scheduled pickup time.
- Equipment must be returned on or before the agreed return time.

2. Late Returns

- Late returns disrupt availability for other customers and are subject to fees:
- Late fee: \$25 per hour late.
- Extended fee: \$150 per additional day beyond the initial 24-hour period.
- Late fees may be charged automatically to the payment method on file.

3. Payment & Authorization

- A valid credit card is required for all rentals.
- Renter authorizes Owner to charge the card on file for rental fees, late fees, cleaning fees, and any damage, repair, or replacement costs.
- Payment authorization may be held until equipment is returned and inspected.

4. Identification Requirements

- A valid government-issued photo ID is required at pickup.
- The individual signing the rental agreement must be the same person providing payment and identification.

5. Equipment Use

- Renter agrees to use equipment only for its intended purpose and operate it safely and responsibly.
- Renter will follow manufacturer guidelines and safety instructions.
- Renter will not modify, loan, or sub-rent the equipment.

6. Condition & Inspection

- All equipment is inspected and documented before and after each rental.
- Renter accepts equipment as-is at pickup.
- Renter must report any issues or damage immediately upon discovery.

- Normal wear is expected. Damage beyond normal wear is the renter's responsibility.

7. Damage, Loss, or Theft

- Renter is financially responsible for damage caused during the rental period, missing or broken components, and loss or theft of equipment.
- If equipment is not returned, or is damaged beyond repair, renter agrees to pay the full replacement value of the equipment.

8. Cleaning Fees

- Equipment must be returned in reasonably clean condition.
- Excessive dirt, debris, concrete, mud, or misuse may result in a cleaning fee charged to the payment method on file.

9. Assumption of Risk & Liability

- Renter acknowledges that the use of tools and equipment involves inherent risk.
- Renter assumes all risks related to equipment use and agrees to hold Owner harmless from liability for injury, property damage, or loss arising from use of the equipment.

10. Refusal of Service

- Owner reserves the right to refuse a rental at its discretion.
- Owner may decline service if equipment is unavailable, improperly requested, or if renter does not meet requirements.

11. Future Trailer Rentals

- Additional requirements may apply to trailer rentals, including tow vehicle compatibility and safety verification.
- Trailer-specific terms will be provided prior to rental.

12. Governing Law

- These Rental Terms are governed by the laws of the State of California.
